- For any item requiring a bond, a 20% administration fee shall be withheld by the NFNL regardless of the outcomes unless otherwise stated. Whole bond monies may be retained by the league on appeals at the determination of the Appeals Chair and/or CEO or Board.
- If in the event that the outcome results in action being taken against a player, official, or member of another Affiliated Club, that Club may also be subjected to an administration fee on top of any financial penalties imposed.

- Lodged Investigation money is only returned if person is found guilty (minus 20% administration fee)
